NOTIFICATION OF THE MINISTRY OF LABOUR

RE: FORM OF THE IDENTIFICATION CARD OF COMPETENT OFFICIAL UNDER THE LABOUR
PROTECTION IN FISHING WORK ACT B.E. 2562 (2019)

By virtue of section 4 and section 16 paragraph three of the Labour Protection in Fishing Work Act B.E. 2562 (2019), the Minister of Labour hereby issues the Notification as follows:

Clause 1. The identification card of competent official shall be in accordance with the form as annexed to this Notification.

Clause 2. The following persons shall issue the identification card of the competent officials:

(1) Heads of agencies at the level of Department and above or person as assigned by the head of agency for the competent officials within the agency but shall not include cases where they fall within the jurisdiction of Provincial Governor;

(2) Governor or person as appointed by the Governor for the competent officials who perform duties within such province;

(3) Commissioner-General of the Royal Thai Police or person as assigned by the Commissioner-General of the Royal Thai Police for the competent officials under the Royal Thai Police;

(4) Commander-in-Chief of the Royal Thai Navy or person as assigned by the Commander-in-Chief of the Royal Thai Navy for the competent officials under the Royal Thai Navy.

Clause 3. Persons appointed be the competent officials shall submit application for identification cards of the competent officials in accordance with the form as annexed to this Notification and attach two photos of the size 2.5 X 3 centimeter, half a body, straight shot, without wearing a hat and dark glasses, with the official uniform or state official's uniform and a certified copy of identification card of the competent official to the commander.

The commander who receives the application under paragraph one shall submit an application to the person who has the power to issue the identification card under clause 2.

Clause 4. The identification card of the competent official shall be used for a period of time as specified in the card but shall not exceed five years as from the issuance of the card.

Clause 5. Upon the issuance of the identification card of competent official to any person, the issuer shall provide a copy and list of identification cards of competent officials with the photos of such persons as evidence at the government agency of the issuer of the identification cards of competent officials and shall notify in writing to the Department of Labour Protection and Welfare.

Clause 6. Regarding the issuance of identification cards of the competent officials, in the case where an identification card of the competent official is expired, lost or damaged, the provisions in clause 1, clause 2, clause 3, clause 4 and clause 5 shall apply *mutatis mutandis*.

Clause 7. Any person who receives a new identification card of competent official or person who holds the card without the right to use such identification card of the competent official any further shall return the card to the issuer of the identification card of the competent official under clause 2 within fifteen days as from the date of receipt of new identification card or having no right to use such identification card.

2. The official emblem shall be two circles overlapping with the outside epicenter of 4.5 centimeters and inside epicenter of 3.5 centimeters. The royal emblem shall be 3 cm. high between the inside and outside circles with Thai alphabet specifying the Ministry, Department or Province at the lower edge;

3. It shall be marked under 2. With red ink or embossed mark;

4. behind the position of the competent official, it shall specify the agency of the competent official.
